Pursuant to the Subject Regulations, we wish to inform you that:

As per SEBI (Listing Obligations and Disclosure Requirements) Regulations Amendment, 2018 a listed entity shall not appoint a person or continue directorship of any person as a non executive director who has attained the age of 75 Years unless a special resolution is passed to that effect. In compliance with this provision following below mentioned directors having age more than 75 years has tendered their resignation-

(i) Mr. Brahm Prakash Bakshi, 80 years (DIN: 00129132), an Non- Executive Independent Director on the Board of the Company has tendered his resignation from the position of an Independent Director with effect from close of business hours of March 31, 2019. Further consequent to the resignation, he has ceased to be the Chairperson of Nomination and Remuneration Committee, Stakeholders Relationship Committee and member of Audit Committee of the Board.

(ii) Mr. Prahlad Rai Chamaria, 77 years (DIN: 00037589), a Non - Executive Director on the Board of the Company has tendered his resignation from the position of Non-Executive Director with effect from close of business hours of March 31, 2019.

Further, In accordance with the Regulation 30 SEBI (Listing Obligations and Disclosure Requirements) Regulations Amendment, 2018 read with Schedule III (Part A) there is no other material reason for their resignation other than mentioned above.
